Foreword

This British Standard is published under the authority of the Plastics Standards Committee. It has been prepared to provide a national standard for plasticized nylon tubing for use primarily in pneumatic installations in conjunction with the compression type fittings used. Part 1 is not intended to cover tubing for use in contact with beverages or foodstuffs, nor is it suitable for domestic central heating systems.

Tubing containing reinforcing agents or fillers is not within the scope of this standard.

In the preparation of this Part attention has been paid to standards prepared by Comité Européen des Transmissions Oléo-Hydrauliques et Pneumatiques (CETOP).

It is intended to prepare further Parts of this standard as follows:

Part 2 Plasticized and unplasticized nylon tubing types 11 and 12, for use primarily in the automotive industry

Part 3 Unplasticized nylon tubing types 6 and 66.
