National foreword

This Section of BS 684 has been prepared under the direction of the Food and Agriculture Standards Committee. It is identical with ISO 7847:1987 “*Animal and vegetable fats and oils — Determination of polyunsaturated fatty acids with a cis,cis 1,4-diene structure*”, published by the International Organization for Standardization (ISO), and in the preparation of which the United Kingdom played a full part.

Terminology and conventions. The text of the International Standard has been approved as suitable for publication as a British Standard without deviation. Some terminology and certain conventions are not identical with those used in British Standards; attention is drawn especially to the following.

The comma has been used as a decimal marker. In British Standards it is current practice to use a full point on the baseline as the decimal marker.

The symbol “l” has been used to denote “litre” (and in its submultiples). In British Standards it is current practice to use the symbol “L”.

Wherever the words “International Standard” appear, referring to this standard, they should be read as “Section of BS 684”.
