BRIEF HISTORY RELATING TO THE FIRST EDITION

The ISO Recommendation R 194, List of equivalent terms used in the plastics industry, was drawn up by Technical Committee ISO/TC 61, Plastics, the Secretariat of which is held by the American National Standards Institute (ANSI).

Work on this question led, in 1956, to the adoption of a Draft ISO Recommendation (no. 177) which was circulated to all the ISO Member Bodies for enquiry in April 1958. It was approved by 23 Member Bodies. No Member Body opposed the approval of the Draft.

This Draft ISO Recommendation was then submitted by correspondence to the ISO Council which decided, in March 1961, to accept it as an ISO RECOMMENDATION.

BRIEF HISTORY RELATING TO THE SECOND EDITION

The ISO Recommendation R 194-1969 combines the terms contained in ISO Recommendation R 194-1961 and in Draft ISO Recommendations Nos. 751 and 1253 which were circulated to the ISO Member Bodies for enquiry in August 1964 and May 1967, respectively.

Draft ISO Recommendation No. 751 was approved, subject to a few modifications, by the following Member Bodies :
